The purpose of this letter is to provide revised schedule information for the PPL Bell Bend, LLC (PPL) response to NRC Request for Additional Information (RAI) No. 121 (Reference 1). RAI No. 121 addresses Probabilistic Risk Assessment and Severe Accident Evaluation, pertaining to the Fukushima Near-Term Task Force (NTTF) Recommendation No. 4.2, as discussed in the Final Safety Analysis Report (FSAR), Part 2 Chapter 19 of the Bell Bend Nuclear Power Plant (BBNPP) Combined License Application (COLA).

Reference 2 indicated that a response to RAI No. 121 would be provided to the NRC on or before July 19, 2013. PPL requires additional time to finalize this response; it will be provided as part of, and concurrent with, PPL’s response to the RAI No. 126 (Reference 3), which also addresses Fukushima NTTF Recommendation 4.2.

The only regulatory commitment in this correspondence is to submit a response to RAI No. 121, concurrent with the response to RAI No. 126.
