Dear CAPT. Davis-Urgo:

This is in reference to your letter dated June 13, 2013 requesting an alternate schedule for submission of the Final Status Survey Reports for the Naval Research Laboratory Chesapeake Beach Detachment and the Naval Surface Warfare Center Dahlgren Division.

You requested an alternate schedule citing 10 CFR 40.42 (i) (1). Since your Master Materials License was issued under the provisions of 10 CFR Part 30, it appears that the most applicable citation for your request is 10 CFR 30.36 (i) (5)... "other factors beyond the control of the licensee".

As discussed with you on July 23, 2013, in order to continue our review, we need the following additional information. Since the NRC must consider all sections of this part, 10 CFR 30.36 (i), 1 through 5, in order to approve a request for an alternative schedule for completion of decommissioning, please provide information addressing all these sections. Please identify those sections that are not applicable, and sufficient information to support the section that does apply.

Guidance for providing this information may be found in NUREG-1757, Volume 3, "Consolidated NMSS Decommissioning Guidance, Financial Assurance, Recordkeeping, and Timeliness", Section 2.6, "Review Criteria for Extension or Alternative Time Schedule Requests."
