2) Physical Description

This shipment will consist of 120 drums of Uranium Ore Concentrate (U-308) in 2 x 20' ocean containers. The total weight of the shipment is 24,709.4 kgs of U-308.

3) Transportation and Route Schedule

The vessel sailed from Adelaide on March 25, 2013. The ocean transportation from Adelaide to Tacoma, WA USA will be the responsibility of Hamburg Sued. The vessel will unload at Tacoma, WA USA on or about April 19, 2013. The inland transportation from Tacoma, WA to Blind River, ON will be the responsibility of RSB LOGISTIC SERVICES, INC.
