Included is written notification in accordance with NRC regulation 35.14.



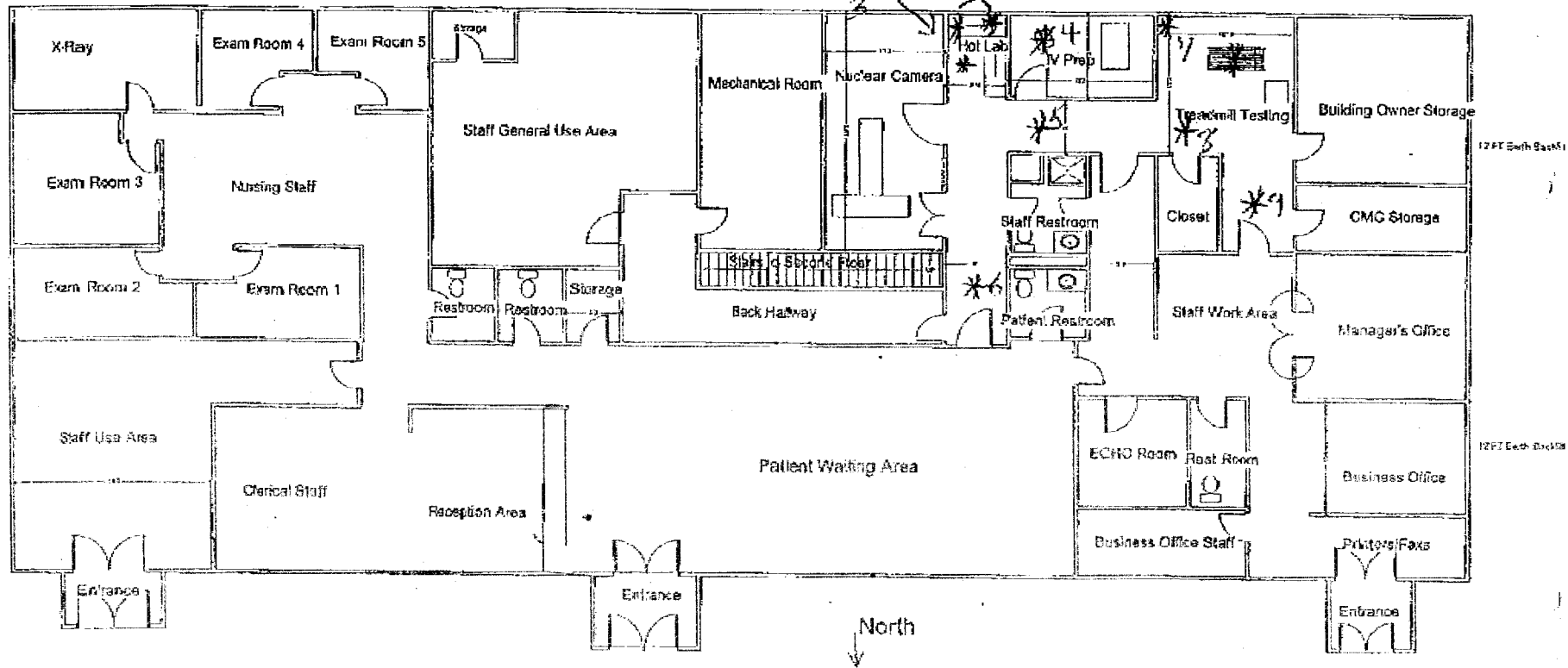
