

Dear Ms. Roldan-Otero

Please be advised that our Radiation Safety Officer, Robert Lantz, is no longer employed with Spokane Rock Products, Inc. I have worked alongside Robert for the last eight years in the laboratory and in the field using our portable nuclear gauges. I completed the Radiation Safety Officer Class on June 21, 2013.
