A draft of the RAI was provided to you on October 10, 2012, and discussed with your staff on October 18, November 26, and November 30 2012. On November 30, 2012, Draft RAI Question 19-356 was modified as a result of those discussions. On November 30, 2012, you informed us that the RAI is clear and no further clarification is needed. The schedule we have established for review of your application assumes technically correct and complete responses within 30 days of receipt of RAIs, excluding the time period of **December 24, 2011 thru January 2, 2012, to account for the holiday season** as discussed with AREVA NP Inc on November 28, 2012.
