SUMMARY

This refers to your request to terminate your license and the phone conversation between Paul Baertlein, Colleen Casey and Jennifer Bishop on May 22, 2013.

- A. In NRC Form 314, "Certification of Disposition of Materials," dated April 9, 2013, you requested that your NRC license be terminated. In support of this request, please provide the following information:
1. **Please provide the last leak test results from only the sources that were used in NRC jurisdiction. If a source is no longer in your possession, please provide the documentation that the source has been properly transferred or disposed of in accordance with 10 CFR 30.41, 10 CFR 30.51 and 10 CFR 34.63.**
 2. **In addition, please confirm, in writing, that there is no history of leaking sources ever possessed under this license. For any instances where there have been leaking sources, please provide the information required by 10 CFR 34.27 and 10 CFR 34.67.**
 3. **The NRC Form 314, "Certification of Disposition of Materials," does not appear to be signed by a senior management certifying official. The completed NRC Form 314 is required in order to complete our review. Please resubmit the NRC Form 314, including all applicable information and a signature by a senior management Certifying Official.**
- B. In NRC Form 314, "Certification of Disposition of Materials," dated April 9, 2013, you state that radiation survey results were forwarded to the NRC on November 11, 2002.

At this time, the NRC cannot locate those surveys.

- 1. Please provide a copy of the surveys that were submitted to the NRC in a letter dated November 11, 2002.**


