Dear Administrative Judges:

In its Order dated March 5, 2009, the Atomic Safety and Licensing Board (“Board”) directed the NRC staff (“Staff”) to tender each month a status report advising as to whether the estimated dates for issuance of the final Safety Evaluation Report (“SER”) (predicted for the late summer of 2009) and the final environmental review document (predicted for December of 2009) have changed.<sup>1</sup> By letter dated July 26, 2013, the Staff informed the Board and the parties of the public availability of the SER. The document can be accessed electronically via ADAMS Accession Number ML110820512. The Staff currently expects to issue the final environmental review document by the end of November 2013.

In keeping with the Board’s mandate, the Staff will tender its next monthly status report by September 16, 2013.
