Dear Administrative Judges:

In its Order dated January 8, 2009, the Atomic Safety and Licensing Board ("Board") directed the NRC staff ("Staff"), commencing on January 15, 2009, to tender each month "a short report advising as to whether the estimated dates for issuance of the final [Safety Evaluation Report ('SER')] (predicted for summer/fall of 2009) and final [environmental review document] (predicted for December of 2009) have changed or become more definitive."

By letter dated January 2, 2013, the Staff informed the Board and the parties of the public availability of the SER. The document can be accessed electronically via ADAMS Accession Number ML103470470.

In order to allot sufficient time for meaningful review and comment by the consulting parties regarding information obtained by the Staff in furtherance of its NHPA Section 106 obligations, the Staff now expects to issue the final environmental review document by the end of October 2013. The Staff anticipates in the near future releasing for public comment information related to its Section 106 evaluation. When such occurs, the Staff will notify the Board and the parties.

In keeping with the Board's mandate, the Staff will tender its next monthly status report by September 16, 2013.
