Sorry it took so long to get back to you. Enrique and I just finished our analysis and thoughts on this effort. Here is what we think.

If this document was a DHS document and it contained Figure 6 on page 14 we would mark it as an FOUO document thus putting handling restrictions on it – not classify it. If Figure 6 was removed we would not place any handling restrictions on it – essentially it would not contain the FOUO markings or any other markings.

We fully understand that since this is the NRC's document you decide whether or not handling restrictions are placed on the document. We will support whichever decision you make.

Please let me know if this meets your needs.

Rich,

I met with the folks that led the development of the IP classification guide and to my surprise IP does not have people on staff that routinely review IP-generated documents to ensure the appropriate classification of documents in accordance with our guide. I was referred to a DHS level "classifying group" that IP uses. I sent the POC for that group an email (without your document attached as I did not want to have it in circulation unless I knew for certain they would be helpful) asking for their assistance. They stated that since they are not dams SMEs they could not help us and referred me back to the IP folks that referred me to them in the first place. I am just in awe of the circular tracts here in DHS.

Therefore, I and my dams folks will take the IP guide ourselves and do our own analysis. We will have something to you early next week. I do not think it will change our discussion much if at all.
