On August 5, 2013, the Commission reinstated its transfer of regulatory authority over Shieldalloy's Newfield site to New Jersey.¹ Based on the Commission's decision, the NRC Staff will not be resuming its review of Shieldalloy's decommissioning plan for the Newfield site. The Staff is currently working with New Jersey state agencies on various tasks related to the reinstatement of regulatory authority with the state.
