Dear Mr. Webb:

Enclosed is Amendment No. 97 to your NRC Materials License No. 13-00142-02 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

In your letter dated July 16, 2013, you requested removal of an authorized location of use at 4015 Gateway Boulevard, Suite 3000, Newburgh, IN. The NRC staff has reviewed this information, including your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from your facility and residual radioactive material attributable to licensed activities does not exceed current NRC criteria.

Based on these conclusions, no further remediation or actions with respect to NRC regulated material is required. Your facility at 4015 Gateway Boulevard, Suite 3000, Newburgh, IN is suitable for unrestricted use.

Please note also that we have amended Item 8.C. to reflect a total possession for all 35.300 material. This change was made due to an NRC policy change. This matter was discussed with your consultant, Mr. Patrick Byrne, via e-mail on August 8, 2013, who agreed to the change.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.


