As we discussed, I have attached the Advance Notification Federal Register Notice (FRN). In addition to this FRN publication in June 2012, a letter was sent to all 566 federally Recognized Tribal leaders on July 6<sup>th</sup> 2012 notifying them of this rule and the steps that need to be taken to "opt in".
