In accordance with 10 CFR 2.390, INFICON requests the information contained in the New York State Department of Health Quarterly Distribution Report's submitted as required under license # C3114 & C3113 be exempted from public disclosure. Our exemption request is based on paragraph (a)(4) with our information falling under the confidential commercial information.

INFICON invests substantial efforts and time to promote our devices which use Ni-63 sources as its sensing technology. Because these devices are used in measuring pollution in both air and water, the marketplace for them is worldwide and expanding.
