We have completed our review of the Final Status Survey Report for Surface Soils in Survey Units 1 and 2 submitted by letter dated August 16, 2011, as supplemented. Based on this review, we confirm that the surface soils in Survey Units 1 and 2 are suitable for unrestricted release.

We note that you must address the potential for recontamination of these areas if substantial time passes before you request release of the site. In addition, we note that this evaluation is limited to soil contamination and that evaluation of other media should be performed separately.

A Safety Evaluation Report documenting the results of our review is enclosed.

This letter concludes our action on this report. This letter also closes the assigned Technical Assignment Control Number L33175.
