
Dear Mr. Bhachu,

1. The document being requested to be withheld from public disclosure is the NRC "Transfer of Industrial Devices Report (To General Licensees)", commonly referred to as the Generally Licensed Device Quarterly Transfer Report, and henceforth referred to as "Confidential Information".
2. I am the President and Radiation Safety Officer of Scan Technologies, Inc.
3. The basis for our request to exempt this report from public disclosure falls under 10CFR Part 2.390(4), as commercially and financially privileged and confidential.
4. The "Confidential Information" we wish to exempt from public disclosure is commercially and financially proprietary and sensitive to Scan Technologies, Inc, and could cause great harm if made public to our competitors. It would also provide information about our vendors for our radioactive sources, which is highly sensitive, financially proprietary information.



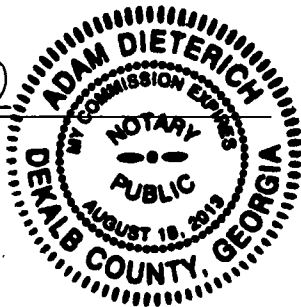
