In Reference 1, SCE&G submitted an Interim Report under the requirements of 10CFR
50.55(e)(3)(ii) pertaining to incorrectly labeled Containment Filtrations System (VFS)
equipment for the V.C. Summer Nuclear Station, Units 2 and 3. The letter stated that the
evaluation to identify a reportable defect or failure to comply that could create a substantial
safety hazard, were it to remain uncorrected, would be complete by August 16, 2013.

This letter is to inform the NRC that CB&I (Chicago Bridge & Iron) as an agent for SCE&G has
investigated this condition and concluded that the condition described is not reportable under
the requirements of 10CFR 50.55(e)(3)(iii). The evaluation has been completed in accordance
with the date stated in the interim report.
