Dear Mr. Colebaugh:

By letter dated May 29, 2013 and NRC Form 314 dated July 29, 2013, Cardiology Associates of New Haven, P.C. submitted to the U.S. Nuclear Regulatory Commission (NRC) a Request for Consent to direct License Transfer of activities and facilities conducted under NRC Materials License No. 06-28459-01. Based on the information you provided, we understand that as a result of a proposed sale of Cardiology Associates of New Haven, P.C. to Yale-New Haven Hospital, control of Cardiology Associates of New Haven, P.C. facilities will directly be transferred to Yale-New Haven Hospital. We further understand that this transfer will not result in any change to licensed material, persons using the licensed material, or location of use of licensed material. Finally, we understand that the Radiation Safety Officer from Yale-New Haven Hospital will oversee the Radiation Safety Program in the facility previously operated by Cardiology Associates of New Haven, P.C.

Based on the above understandings and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report which documents the NRC staff's review of the request, we have no objection to the proposed transfer. We understand that the sale took place on May 1, 2013. Please find enclosed Amendment No. 12 terminating License No. 06-28459-01 as requested by your letter dated May 29, 2013 and NRC Form 314 dated July 29, 2013. This action is being done concurrently with transferring your facilities and sources to the Yale-New Haven Hospital License No. 06-00819-03 under Mail Control Number 581035. This termination is being issued in accordance with the requirements of the applicable NRC License Termination Rule (10 CFR 30.36).
