REQUEST FOR ADDITIONAL INFORMATION CONCERNING APPLICATION  
FOR AMENDMENT TO LICENSE, CONTROL NO. 581561

Dear Mr. Aldrich:

This is in reference to your letter dated August 9, 2013, and August 21, 2013, requesting to amend Nuclear Regulatory Commission License No. 06-35047-01. In order to continue our review, we need the following additional information:

1. As stipulated in Ms. Ullrich's letter to you on March 29, 2013, in order to have an animal release criteria of 0.5 millirem per hour measured at 1 meter from the animal, the animal and its owner needs to be pre-screened to determine if the release of the animal can be accomplished under the limitations of the owner's care. It also requires that you perform post-administration evaluations of the animal to ensure that instructions are followed or if instructions need amended. Your request did not commit to these items. The licensee must assure that the dose to individual members of the public (including family members) from a cat treated with I-131 does not exceed the 100 millirem annual public dose limit in 10 CFR 20.1301. Please commit to pre-screening the animal and its owner before using this release criteria and to perform post-administration evaluations of the animal to ensure that instructions are followed or if instructions need amended.
2. In your letter you informed us that you would be changing your legal name to "Central Hospital for Veterinary Medicine." You did not inform us when this change will occur. When will the legal name be changed?
3. You are moving into your new facility located at 4 Devine Street, North Haven, Connecticut, on November 1, 2013; however it appears that you wish to use the outside storage area earlier than this date. This location may be added to your license once it is no longer occupied by any previous tenants. Is this location new construction? If not, when will the previous occupants vacate the facility?
4. You referenced 10 CFR 35 in your letter associated with holding radioactive waste for decay. Please note that you are not licensed under 10 CFR 35. Your authorization for

allowing radioactive waste to decay is contained in License Condition 14. You must comply with this license condition. You do not need to response to this paragraph.
