Accordingly, the following changes are hereby made: Section A.2 CONSIDERATION AND OBLIGATION-COST-PLUS-FIXED-FEE (AUG 2011) ALTERNATIVE 1 (AUG 2011), paragraph (c) is deleted in its entirety and the following is substituted in-lieu thereof:

"(c) The amount currently obligated by the Government with respect to this contract is \$85,000.00, of which the sum of \$80,952.38 represents the estimated reimbursable costs, and of which \$4,047.62 represents the fixed-fee."


