SUBJECT: SUMMARY OF AUGUST 20, 2013, PUBLIC MEETING WITH

THE U.S. NUCLEAR REGULATORY COMMISSION STAFF AND NUSCALE POWER, LLC, TO DISCUSS THE NUSCALE DESIGN

SPECIFIC REVIEW STANDARD (DSRS) UPDATE AND CHAPTER 7 DSRS DEVELOPMENT (TAC No. RN6110)

On August 20, 2013, a public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) and representatives from NuScale Power, LLC (NuScale) at the NRC Offices at Three White Flint North, 11601 Landsdown Street, North Bethesda, MD 20852, Room 03-A28.

The purpose of this meeting was for NuScale personnel to discuss their perspective on the general applicability of existing Standard Review Plans (NUREG-0800, Standard Review Plan for the Review of Safety Analysis Reports for Nuclear Power Plants: LWR Edition) and related Design Specific Review Standards (DSRS) to NuScale systems and to indicate where new or modified DSRS's may be required due to different or unique NuScale systems. NuScale also discussed their design approach for instrumentation and control (I&C) systems.

Additionally, the NRC staff made a presentation on the licensing review methodology that will be used for small modular reactor instrumentation and controls systems. The NRC staff also provided the status and schedule for the preparation of the NuScale DSRS's.
