I am the license reviewer that will be handling the review and renewal of NRC License No. 13-15544-01, issued to PSI Energy, Inc. at the Gibson Generating Station. I have not yet fully reviewed the submittal dated 04/26/13, so I do not have any questions specifically about that at this time. However, there is one item I know we will need to have addressed as we move forward.

This is in regards to the apparent name change/change-of-control of PSI Energy to Duke Energy. In order to evaluate and document this, I will need some additional information. I have attached 2 versions of NUREG-1556, Vol 15, App F that contains 6 Questions that we use to review a change-of-control and/or name changes. Could you please address these Questions (or have them addressed by your legal staff) and provide me with a response?

I provided the 2 versions in case one was more helpful in preparing the response.

I would ask that the response be returned within 30 days (July 19, 2013) as it will need to be evaluated along with the renewal application.

When you return the response to me, please simply email it to me. I would suggest a signed cover letter with the responses to the 6 Questions. Put the whole document in PDF format and attach it to the email.

Bryan,

Thank you for your patience. I have received information/language below which should better answer your questions. Please review the information below and let me know if it is satisfactory, or if you have further questions.

- Gibson Station was built between 1976 and 1982 by Public Service Company of Indiana, Inc. ("PSC")
- PSC was a wholly-owned subsidiary of PSI Resources, Inc. ("Resources").
- On April 20, 1990, PSC changed its name to PSI Energy, Inc. ("PSI").
- On October 24, 1994, Resources merged with and into Cinergy Corp. ("Cinergy"), and PSI became a wholly-owned subsidiary of Cinergy.
- On April 3, 2006, Cinergy merged with and into a subsidiary of Duke Energy Corporation ("Duke"), and PSI became a wholly-owned subsidiary of Duke.
- On October 1, 2006, PSI changed its name to Duke Energy Indiana, Inc.

I think it is important to note that at no time did the ownership of Gibson Station change. What did change were the companies who owned the company owning Gibson (since the owner of Gibson was a subsidiary company) and the names of some of the companies.
