Dear Sir or Madam:

In Reference 1, the NRC issued the Request for Information for Near-Term Task Force Recommendations related to the Fukushima Dai-ichi accident. In Reference 2, Energy Northwest committed to submit a final report documenting the results of the seismic walkdowns no later than November 27, 2012. In Reference 3, Energy Northwest submitted an Initial Seismic Walkdown Summary Report and committed to provide the NRC with a final seismic report within sixty days after startup from Refueling Outage R21 documenting the results of seismic walkdowns on the inaccessible items identified in Section 5.4 of the Initial Seismic Walkdown Summary Report. Additionally, Energy Northwest also committed in Reference 3 to provide a status of the open condition reports identified in Section 6.9 and Attachment 13 of the Initial Seismic Walkdown Summary Report.
