The purpose of this modification is to (1) exercise option year 2, thereby extending the Period of Performance (POP) through September 30, 2014, and (2) obligate funds in the amount of \$850,000.00. Accordingly the task order is modified as follows:
1. The Period of Performance is revised to read as: "March 1, 2013 - September 30, 2014."
2. The ceiling is increased by \$250,384.06 from \$1,076,720.94 to \$1,825,000.00.
3. The total obligated amount is increased by \$850,000.00 from \$975,000.00 to \$1,825,000.00.
