Dear Mr. Morris:

This letter is in reference to your e-mails, dated August 17, 21, 23, and 27 2013 (U.S. Nuclear Regulatory Commission's (NRC's) Agencywide Documents Access and Management System (ADAMS) Accession No. ML13079A299) that you filed electronically with the NRC. You request that the NRC require new-design programmable logic computers be installed in the control systems of nuclear power plants.

Your e-mails were in response to the August 9, 2013, letter that the Executive Director for Operations sent you noting that your initial request dated March 14, 2013 (ADAMS Accession No. ML1307A185); did not fully meet the Commission's criteria under § 2.802(c) of Title 10 of the *Code of Federal Regulations* (CFR) for a petition for rulemaking (PRM). The letter also noted that if you would like the NRC to further consider your request as a PRM, you must supplement your request within 90 days to meet the minimum requirements for a PRM.

The NRC docketed your petition pursuant to § 2.802, "Petition for rulemaking," on September 10, 2013, and assigned it Docket Number PRM-73-17. Please reference this docket number on any correspondence you may have concerning the petition.
