Dear Mr. Crouch:

Enclosed is Amendment No. 84 renewing your NRC Material License No. 13-00108-05 in accordance with your request. Note that, in accordance with letter dated August 28, 2013, we have removed Item 6.J., as listed previously on your license. We have also revised Condition 14, in accordance with your application and current licensing policy.

We have noted that the application dated March 4, 2013, omitted the Cardwell, Montana, field station, listed previously on your license, and that the August 28, 2013, letter included a request to remove that location of use from your license. The NRC staff has removed final sealed source removal information for the Indiana University Geologic Field Station in Cardwell, Montana. Based on its review, the staff has concluded that the referenced location of use is suitable for unrestricted use.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
