Dear Dr. Roberts:

Enclosed is Amendment No. 31 to your NRC Materials License No. 24-17450-01 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

As requested in your application dated June 11, 2013, we have added the information defining the roles and responsibilities of personnel related to radiation safety.

Also, in letter dated June 17, 2013, to Ms. Patricia H. Duft, Vice President, Legal, the NRC gave its consent to an indirect transfer of control of licensed activities to Mallinckrodt plc. As a result of that transaction, which occurred on June 28, 2013, we have amended your license noted above to add information related to the finalized transfer of control contained in letters dated July 11 and 18, 2013, provided by Mr. Eric Berry, Vice President, Environmental Law.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. We strongly encourage you to review this material and adapt it to your particular needs in order to develop and maintain a positive safety culture as you engage in NRC-regulated activities.


