**SUBJECT: GUIDANCE ON USE OF WIRELESS DEVICES IN AREAS HAVING
U.S. DEPARTMENT OF ENERGY ACCREDITED CLASSIFIED NETWORKS**

In a letter dated November 13, 2013, the U.S. Department of Energy (DOE) provided guidance (enclosed) on the use of wireless transmitting devices in classified areas which have DOE authorized and/or accredited classified cyber networks. This guidance was developed as a result of a recent issue identified at a U.S. Nuclear Regulatory Commission (NRC) fuel cycle licensee. Because of the generic nature of the guidance, we are providing it to all NRC fuel cycle licensees with DOE authorized networks.

Current licensees should review this information for applicability to their facilities, as well as their vendors and contractors that possess or use classified matter and utilize classified cyber networks.

In accordance with Title 10 of the *Code of Federal Regulations* 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of the NRC's ADAMS.
