Technical Assistance with Tsunami and Storm Surge Hazard Assessment at Nuclear Power Plant Sites in the United States

On September 9, 2013, as a result of a competitive negotiated acquisition, a labor hour-cost reimbursement (travel only) type contract (NRC-HQ-13-C-42-0051), was awarded to Taylor Engineering, Inc. of Jacksonville, FL, for contractor support to provide the NRC with a technical basis for reviewing tsunami and storm surge/seiche site characteristics to existing nuclear power plant operators. The period of performance is from September 15, 2013, to September 14, 2016, with no options. The total value of the contract is \$2,826,160.

Waste Confidence -- Continued Storage of Spent Nuclear Fuel: Proposed Rule and Draft Generic Environmental Impact Statement; 10 CFR Part 51 (RIN 3150-AJ20; NRC-2012-0246)

On September 13, 2013, the NRC published a proposed rule in the *Federal Register* ([78 FR 56776](#)) proposing to revise its generic determination on the environmental impacts of the continued storage of spent nuclear fuel beyond a reactor's licensed life for operation and prior to ultimate disposal. The NRC prepared a draft environmental impact statement (DGEIS), NUREG-2157, "Waste Confidence Generic Environmental Impact Statement" ([78 FR 56621](#)), to support the proposed rule. The public comment period on the proposed rule and the DGEIS will close on November 27, 2013.

Compatibility of Generally Licensed and Exempt Devices: Petition for Rulemaking; Denial; 10 CFR Part 32 (PRM-32-7; NRC-2012-0127)

On September 16, 2013, the NRC published a denial of a petition for rulemaking (PRM), PRM-32-7, in the *Federal Register* ([78 FR 56839](#)) submitted by Mr. Sean Chapel (the petitioner) on behalf of the Association of Device Distributors and Manufacturers. The petitioner requested that the NRC create a new regulation for exempt devices similar to the NRC's regulations for generally licensed devices. The petitioner also requested that the NRC change the Agreement State compatibility designation of the regulations applicable to generally licensed devices that are specified in § 31.6 of Title 10 of the *Code of Federal Regulations* from "C" to "B." The NRC is denying the PRM because the petitioner failed to present any significant new information or arguments that would support the requested changes, nor did the petitioner demonstrate a need for a new provision for exempt devices. The docket for PRM-32-7 was closed on September 16, 2013.

Proposed Waste Confidence Rule and Draft Generic Environmental Impact Statement; Public Meetings; 10 CFR Part 51 (RIN-3150-AJ20; NRC-2012-0246)

On September 19, 2013, the NRC published a document in the *Federal Register* ([78 FR 57538](#)) informing the public that it will be holding public meetings in October and November 2013, to receive public comments on its proposed amendments to the NRC's regulations pertaining to the environmental impacts of the continued storage of spent nuclear fuel beyond a reactor's licensed life for operation and prior to ultimate disposal ([78 FR 56776](#) and [78 FR 56621](#); September 13, 2013).

**Browns Ferry Nuclear Plant, National Fire Protection Association (NFPA) Standard 805
Regulatory Audit**

During the week of September 9, 2013, the staff conducted an NFPA 805 regulatory audit at the Browns Ferry Nuclear Plant Units 1, 2, and 3. The staff reviewed NFPA 805 transition documents related to Browns Ferry NFPA 805 license amendment request. Browns Ferry staff and their contractors conducted presentations, participated in technical discussions, and coordinated plant tours to help the NRC staff gain a better understanding of the Browns Ferry NFPA 805 license amendment request.

Reactor Oversight Process Working Group Public Meeting

On September 11, 2013, the staff conducted the Reactor Oversight Process Working Group (ROPWG) public meeting. Meeting participants included NRC staff and industry representatives. Discussion included updates on inspection and performance assessment topics, changes to the performance indicator guidance, and frequently asked questions. The next ROPWG public meeting will be held on October 23, 2013.
