Dear Mr. Walther-Meade:

I am responding to your petition request of August 10, 2013, pursuant to Title 10, Section 2.206, "Request for action under this subpart," of the *Code of Federal Regulations* (10 CFR) to the Executive Director for Operations (EDO) of the U.S. Nuclear Regulatory Commission (NRC). As the basis for your request, you stated that Cargo Security Management International (CSMI) committed willful violations involving falsification of information that are of particular concern because the NRC's regulatory program is based on licensees acting with integrity and communicating with candor. You requested that the NRC take immediate enforcement action by issuing an order to revoke CSMI's License #20-35022-01.

The full text of your request is publicly available on the NRC's Web site, www.nrc.gov, through the Agencywide Documents Access and Management System (ADAMS), using Accession No. ML13226A020. The EDO assigned your petition request to the Office of Federal and State Materials and Environmental Management Programs (FSME) for review. Management Directive (MD) 8.11, "Review Process for 10 CFR 2.206 Petitions," which is publicly available (ADAMS Accession No. ML041770328), describes the NRC's review process for 10 CFR 2.206 petitions.

On August 16, 2013, the FSME petition manager contacted you by electronic mail (e-mail) to describe the 10 CFR 2.206 process. You were also offered an opportunity to address the 2.206 Petition Review Board (PRB) to discuss your petition request during an NRC public meeting, which you accepted. On September 10, 2013, you met with the PRB during an NRC public meeting (ADAMS Accession No. ML13238A061). The transcript of that meeting is publicly available at ADAMS Accession No. ML13263A388.

On September 3, 2013, the PRB met internally to discuss your request for immediate action and a second time on September 18, 2013, to discuss your petition, as supplemented on September 10, 2013.

On October 04, 2013, the FSME petition manager informed you that your immediate enforcement action request was denied because there is no immediate impact on public health and safety, national security or the environment at this time. The petition manager also informed you that your petition met the criteria for review in accordance with MD 8.11, Section III.C, "Criteria for Reviewing Petitions Under 10 CFR 2.206," and offered you a second opportunity to address the PRB. You did not request a second opportunity to address the PRB. The PRB's final recommendation is to accept your petition for review under 10 CFR 2.206.
