Hi Manny,

During our visit to Turkey Point, the applicant showed an updated map of their boring plan during a powerpoint presentation on the first day. They provided us with a black and white copy of this map showing this updated boring plan, however the map is quite dirty from being in the field and my notes. I am organizing a presentation to our branch on our audit and would like to show the most up to date boring plan to help orient the group to the site and geotechnical tests conducted during our visit. Would it be possible for the applicant to provide an electronic copy of the most up to date boring plan (either as a PDF, image file, or powerpoint slide)?

I am also interested in viewing the boring plan map data in GIS. Would it be possible to also send GIS shapefiles of the bore hole locations and the digital file of the aerial photograph depicting the site? Rolando also mentioned to me that they had mapped lineaments (to investigate possible fault scarps) by examining a combination of LIDAR-derived elevation data and satellite and aerial photography. Is there a map of these lineaments that I could take a look at? A PDF version of would be ok, but I would also be interested in any shapefiles depicting lineaments, LIDAR, or aerial/satellite photographs used that is possible.

To simplify and clarify, here are the two things I am interested in getting from the applicant if possible:

1. Map showing updating boring plan
2. Any available GIS data for the site
