2. Delete Section A.2 "TASK/DELIVERY ORDER PERIOD OF PERFORMANCE (AUG 2011) and replace with:

"This order shall commence on 5/30/2013 and will expire on 2/28/2014"

3. Add the following to Section A.3 "STATEMENT OF WORK – Services and Deliverables":

"5. Based on the high-level feedback and recommendations from the offsite provided in Deliverable 4., assist NRO working groups in conducting deeper analysis and developing a more defined path forward, to include:

- Identify more detailed actions and approaches NRO could take in regard to the analysis of higher level recommendations provided from Deliverable 4;
- Identify the steps necessary for successful implementation of the actions;
- Assist the team in developing communication strategies for engaging staff and keeping the Office apprised of their activities."

4. Delete Period of Performance from Section A.3 "STATEMENT OF WORK" and replace with the following:

"All services shall begin no earlier than the date of award and must be completed February 28, 2014. If services cannot be completed by the period of performance end date, then written justification must be provided to the COR. The period of performance can only be extended by the Contracting Officer, by way of written modification to the Task Order."
