Planning and Logistical Support for the NRC's Regulatory Information Conference

On September 25, 2013, as a result of a full and open competitive solicitation, a firm-fixed-price and indefinite quantity hybrid contract (NRC-HQ-13-C-03-0057) was awarded to Bethesda North Marriott Hotel and Conference Center of Rockville, MD. This contract will provide meeting space and audiovisual services the NRC Regulatory Information Conference. The period of performance is from September 25, 2013, to September 30, 2014, with two 1-year option periods. The total value of the contract is \$720,627, inclusive of all options.

Technical Surveillance Counter Measures

On September 27, 2013, as a result of a competitive General Services Administration Schedule solicitation, a labor-hours delivery order (GS35F154AA/NRC-HQ-13-F-10-0001) was awarded to Security Management and Integration Company of Tacoma, WA. This contract will provide technical surveillance countermeasures services at NRC headquarters buildings and other NRC-designated locations. The period of performance is from October 1, 2013, to September 30, 2014, with four 1-year option periods. The total value of the contract is \$284,825, inclusive of all options.

**Special Session on State-of-the-Art Reactor Consequence Analyses (SOARCA) at
American Nuclear Society's Probabilistic Safety Assessment (ANS PSA) 2013
conference:**

On September 26, 2013, RES staff and a contractor from Sandia National Laboratories presented five papers on the SOARCA Peach Bottom Uncertainty Analysis (UA) at the ANS PSA 2013 conference. These five papers were presented in a special technical session on SOARCA that was organized by the conference's technical program committee. The session was chaired by two members of the former external peer review committee of the SOARCA project and was very well attended.

Public Meeting with FirstEnergy Nuclear Operating Company (FENOC):

On September 24, 2013, the staff attended a public meeting in Pittsburgh, Pennsylvania, with representatives of FirstEnergy Nuclear Operating Company (FENOC). This "All-FENOC" meeting provided an opportunity for FENOC senior management to update NRC on the status and various initiatives for the Beaver Valley, Davis-Besse, and Perry sites. Topics of discussion included: corporate strategic direction, Fukushima-related activities at all of the FENOC sites, National Fire Protection Association Standard 805 status for Beaver Valley and Davis-Besse, upcoming steam generator replacement at Davis-Besse and Beaver Valley-2, and Perry's strategic improvement plan.

Public Meetings with Pacific Gas and Electric Company:

On September 24, 2013, the staff held a public meeting with Pacific Gas and Electric Company (PG&E) to discuss its plans to submit a license amendment to change emergency diesel generator technical specification surveillance requirements for Diablo Canyon Power Plant, Unit Nos. 1 and 2. PG&E plans to submit the amendment in December 2013.

On September 25, 2013, the staff held a public meeting with PG&E to discuss its plans to submit a license amendment to change emergency core cooling system evaluations, including leak-before-break assumptions, used in 10 CFR 50.46 evaluations for Diablo Canyon Power Plant, Unit Nos. 1 and 2. PG&E plans to submit the amendment in December 2013.

On September 26, 2013, the staff held a public meeting with PG&E to discuss its plans to submit a license amendment to adopt Technical Specifications Task Force Traveler 505, "Risk – Informed Extended Completions Times – RITSTF Initiative 4B," at Diablo Canyon Power Plant, Unit Nos. 1 and 2. PG&E plans to submit the amendment in November 2013.

On October 2, 2013, the staff held a public meeting with representatives of PG&E to discuss its plans to submit a relief request for approval of an alternative for the disposition of laminar indications in pressurizer safety nozzle welds.
