14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.) The purpose of this modification is to de-obligate excess funds and close out the Task Order. Therefore, the task order funding is decreased from \$6,402,046.26 by \$63.39 to \$6,401,987.87. The Task Order obligation amount may differ slightly from contractor records, due to posting of payment activities between multiple task orders and multiple JCNS. The overall obligations and payments for the entire contract of \$59,349,317.10 are the same for both NRC and the contractor.
