On July 11, 2013 the assets and real estate of the former South Bend Ethanol Assets, LLC ("SBEA") ethanol plant located at 3201 Calvert Street, South Bend IN were purchased by Noble Americas South Bend Ethanol, LLC ("NASBE") as a result of a direct sale. The former SBEA facility is now under ownership and control of NASBE. This notification is intended to satisfy the requirements of 10 CFR 31.5(8)(ii)(A), (B) & (C).

Due to this purchase of assets, NASBE would like to formally request to transfer all devices that were previously assigned to SBEA under Recipient Code 710455. A list of these devices is included as "Attachment A" of this request. Please make note of the following:

- 1. All devices currently located at the facility are still at the facility and are accounted for.
- 2. The intended use of the specifically listed devices has not and will not change.
- 3. All of the devices listed in Attachment A have been inventoried and accounted for.
- 4. All devices listed in Attachment A will be under the ownership & control of NASBE.
- 5. If any of the devices listed in Attachment A are to be disposed of while under the ownership/control of NASBE, it will follow all proper disposal regulations as they apply to these devices.
- 6. All devices are secured from unauthorized removal. The facility is staffed 24 hours a day and secured by a perimeter fence.

Please note that as of the date of this notification, all devices are still located at 3201 West Calvert Street, South Bend, IN 46680 (the "facility") and the facility is staffed and secured 24/7.
