- 9. Authorized place of use: The materials specified in Conditions 6.A and 6.C shall be used in the Breazeale Nuclear Reactor Facility and the Academic Projects Building located at University Park, Pennsylvania. The authorized examinations and tests may be performed in the Academic Projects Building or the Breazeale Nuclear Reactor Facility. The materials specified in Conditions 6.D and 6.E shall be used in locations specified in the application.
- 10. Authorized use: The materials specified in Conditions 6.A, 6.D, 6.E and 6.H shall be used in accordance with the statements, representations, and conditions specified in the application dated May 22, 2003, except as modified by other conditions in this license; by revisions submitted on October 9 and November 12 and updated by email dated November 25, 2009; and by the application dated October 13, 2011, as supplemented on February 10, 2012; responses to requests for additional information dated March 29, 2012; and summary of a conference call on April 5, 2012, dated April 7, 2012; letter dated July 15, 2013; letter dated September 23, 2013, (change in officer portion) and letter dated October 8, 2013.
- 11. Insertion of source or special nuclear material (SNM) covered by this license into a nuclear reactor is not authorized.
- 12. The authorizations to use the radioactive materials, issued by the University Isotopes Committee, shall be grated for a three-year period. For continuing work, a new request is to be approved by the University Isotopes Committee prior to the expiration of an existing authorization.
- 13. Suitable clothing (lab coats, gloves, etc.) specific to the job shall be required for work with unencapsulated SNM. Hands, feet and clothing shall be monitored when leaving an area where the material is used. Except by approval of the University Health Physicist, persons shall not exit an area if personal clothing and/or skin are contaminated above background levels.
- 14. The maximum "start-up" or "driving force" used in conjunction with the subcritical assembly shall not exceed that of a 5 curie Pu-Be neutron source.
- 15. Surface contamination surveys in laboratories shall be conducted daily when unencapsulated SNM or spent fuel samples are used. Routine radiation surveys shall be conducted monthly in areas where radioactive materials are used and/or stored.
- 16. Release of equipment, facilities or packages to the unrestricted area or to uncontrolled areas onsite shall be in accordance with the attached, "Guidelines for Decontamination of Facilities and Equipment Prior to Release for Unrestricted Use or Termination of Licenses for Byproduct, Source or Special Nuclear Material," dated April 1993.
- 17. Sealed plutonium sources shall be subject to the leak testing and actions specified in the attached, "License Condition for Leak Testing Sealed Plutonium Sources," dated April 1993.
- 18. Plutonium alpha sources shall be subject to the actions specified in the attached, "License Condition for Plutonium Alpha Sources," dated April 1993.
- 19. The licensee shall comply with 10 CFR Part 71 for packaging and transportation of radioactive
