(PRE-GI-0014) ON MAN-MADE EXTERNAL HAZARDS

The Generic Issues Program has completed its acceptance review of the proposed generic issue (GI) that you submitted via memorandum (ML12328A180) related to the potential increase in risk due to man-made activities attributable to changes in site environs. As noted in your submittal, the Japan Lessons-Learned Project Directorate (JLD) Senior Level Screening Group recommended that staff look into "other external hazards" that include events pertaining to co-located facilities, near-by facilities, and other site-specific external hazards. The JLD Steering Committee recommended pursuing this topic under other regulatory processes such as the Generic Issue Program (GIP). The GIP staff has performed an acceptance review and entered this issue, designated as PRE-GI-0014, into the Generic Issues Management Control System for tracking purposes.

In a meeting with NRR/JLD and RES/DRA on November 19, 2013, possible paths forward were discussed. In addition to options mentioned in the White Paper, rulemaking or initiation of a User Need Request to develop a technical basis for rulemaking were discussed. We have concluded that the proposed GI does not satisfy several criteria for acceptance as a Generic Issue. Details on our review are contained in the enclosure. The determinations of this acceptance review are final unless new information is provided that necessitates a reassessment against the Generic Issues Program criteria. However, any correspondence that may provide new information should be submitted for review and evaluation. Thank you for proposing this issue for Generic Issues Program review.
