The purpose of this letter is to provide a follow-up report for Technical Specification fire-related assemblies (specifically fire doors) found inoperable during routine surveillances in October 1989. This monthly report and previous monthly reports provide updated information associated with the initial 1983 report.

The enclosed report identifies 14 latching mechanism failures and 14 closure mechanism failures. As each of these deficiencies was identified, compensatory fire watches were established pursuant to Technical Specification 3.7.9, Action Statement "a." No doors were found to be blocked open in October.
