**SUBJECT: DAVIS-BESSE NUCLEAR POWER STATION, UNIT 1, NOTIFICATION OF NRC
INSPECTION**

Dear Mr. Lieb:

In a telephone conversation on October 18, 2013, Mr. M. Bielby, Operator Licensing Branch, and Mr. A. Stallard, Superintendent, Nuclear Operations, revised arrangements for the U.S. Nuclear Regulatory Commission (NRC) to conduct an inspection using Temporary Instruction (TI) 2515-186, "Inspection of Procedures and Processes for Responding to Potential Aircraft Threats," at Davis-Besse Nuclear Power Station, Unit 1. This inspection was changed from the week of October 7, 2013, to the week of November 18, 2013.

The NRC inspector will require a shift crew and a qualified security supervisor individual for a simulator scenario to allow inspection of TI 2515-186 attributes. In order to minimize the impact to your onsite resources, and to ensure a productive inspection for both sides, please have available the procedures that would be followed to respond to an aircraft threat and any related lesson plans pertinent to the inspection. Additionally, the inspector needs to review your aircraft threat procedure and a list of corrective action reports regarding security and licensed operator issues, the week before the inspection.

This letter does not contain new or amended information collection requirements subject to the *Paperwork Reduction Act of 1995* (44 U.S.C. 3501 et seq.). Existing information collection requirements were approved by the Office of Management and Budget, Control Number 3150-0011. The NRC may not conduct or sponsor, and a person is not required to respond to, a request for information or an information collection requirement unless the requesting document displays a currently valid Office of Management and Budget Control Number.
