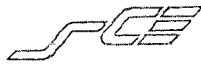

Enclosed are Amendment Application No. 51 to Facility Operating License NPF-10 and Amendment Application No. 37 to Facility Operating License NPF-15 for San Onofre Nuclear Generating Station, Units 2 and 3, respectively. Amendment Application No. 51 for Unit 2 and Amendment Application No. 37 for Unit 3 consist of Proposed Technical Specification Change NPF-10/15-256 (PCN-256). PCN-256 is a request to revise Technical Specification 3/4.3.1, "Reactor Protective Instrumentation," and Technical Specification 3/4.3.2, "Engineered Safety Features Actuation System Instrumentation." The proposed change would revise the 18 month surveillance intervals to "refueling interval" to support nominal 24 month fuel cycle operation.
