This letter is to inform you that the additional information requested by the NRC on rack row deletion analysis associated with the reracking License Amendment Request (LAR) for San Onofre Units 2 and 3 will be submitted by February 28, 1990. This information was promised in the referenced letter to be submitted by February 9, 1990.

During review of the latest vendor drawings on the single failure proof temporary gantry crane (TGC) and other reracking documentation, several items were identified which required changes to the reracking licensing report. The finalization of the TGC design, which occurred after submittal of Rev. 5 to the reracking LAR, resulted in increases to several heavy load weights. These increased weights required reanalysis of several heavy load drop calculations. Also, four new required construction heavy load lifts have been identified which are being included in the Reracking LAR.

The analyses and evaluations required to address the increased heavy load lift weights and new heavy load lifts have caused the above mentioned delay in our submittal of Revision 6 to the Reracking LAR. Revision 6 is currently in our review and approval process.
