Enclosed are three executed and forty conformed copies of Amendment Application No. 18 to Operating License NPF-10 and Amendment Application No. 4 to Operating License NPF-15 for San Onofre Nuclear Generating Station Units 2 and 3. Amendment Application Nos. 18 and 4 consist of the following proposed changes:

1. Proposed Changes NPF-10-62 and NPF-15-62 are requests to revise Technical Specifications 3/4.3.2 (Table 3.3-5) ENGINEERED SAFETY FEATURES SYSTEM ACTUATION INSTRUMENTATION and 3/4.5.2 ECCS SUBSYSTEMS - Tavg GREATER THAN OR EQUAL TO 350°F to allow plant modifications to mitigate the consequences of simultaneous occurrence of a Safety Injection Actuation Signal and a Recirculation Actuation Signal.
2. Proposed Changes NPF-10-64 and NPF-15-64 are requests to revise Technical Specification 4.5.2.f EMERGENCY CORE COOLING to reduce High Pressure Safety Injection (HPSI) pump performance requirements for power levels less than 83%.

Southern California Edison Company's (SCE) letter of December 29, 1982, requested early approval for Proposed Changes NPF-10-62 and NPF-15-62. Early approval was granted by the NRC with the issuance Amendment Nos. 13 and 2 to Operating Licenses NPF-10 and NPF-15, respectively, on December 30, 1982.

SCE's letter of January 14, 1983, submitted Proposed Changes NPF-10-64 and NPF-15-64 to the NRC for early approval. The fact that two Unit 2 HPSI pumps have been demonstrated to meet existing technical specification criteria reduces the urgency for approval of the proposed changes requested in the January 14 submittal. However, surveillance testing is due for two of the Unit 3 HPSI pumps by March 31, 1983. Therefore, timely consideration and approval of Proposed Changes NPF-10-64 and NPF-15-64 is requested to avoid the potential for another "emergency" technical specification request when surveillance testing of the Unit 3 HPSI pumps is again required.

Direct distribution of Amendment Application No. 18 to Operating License NPF-10 and Amendment Application No. 4 to Operating License NPF-15 will be made in accordance with the service list provided in SCE's August 2, 1982 letter to the Commission. An affidavit attesting to the fact that distribution has been completed will be submitted within ten days of amendment docketing.

Based on determinations made in accordance with 10 CFR 170.22, the Proposed Changes contained in Amendment Application No. 18 to Operating License NPF-10 are each considered to constitute a Class III amendment. The identical Proposed Changes contained in Amendment Application No. 4 to Operating License NPF-15 are each considered to constitute a Class I amendment. Accordingly, enclosed is SCE's check for \$8,800 as required by 10 CFR 170.22.
