Enclosed for your review and approval is a copy of a proposed change to Unit 2 Technical Specification 4.0.2 relating to surveillance intervals. The proposed change requests a delay until October 1, 1983 for those 18 month interval surveillance requirements which cannot be completed without an extended outage in the intervening period. The request is made to avoid an undesirable interruption of the remainder of the startup test program and an extended outage during Southern California Edison Company's (SCE) summer peak load period.

As the limiting surveillance requirement is due on July 12, 1983, approval of the proposed change is requested by that date. Based on the discussion included in the attached proposed change, SCE considers that the proposed change does not involve any significant hazard considerations not described or implicit in the Final Safety Analysis.

The proposed change is submitted by this letter, rather than by a formal amendment application, to facilitate the required pre-noticing in the Federal Register and processing of the amendment on a routine basis by July 12, 1983. A formal request for an amendment to Operating License NPF-10 will be submitted by July 1, 1983. In accordance with 10 CFR 170.22, this change has been determined to constitute a Class II amendment. A check for \$1,200.00 corresponding to this determination is enclosed.
