This amendment application consists of the following proposed changes to Facility Operating License NPF-10:

Proposed Change NPF-10-79 is a request to revise Technical Specifications 6.9.1.10, 6.13, 6.14 and 6.15 to correct an inconsistency relating to the review of revisions to the Offsite Dose Calculation Manual, Process Control Program and major changes to Radioactive Waste Treatment Systems.

Proposed Change NPF-10-82 is a request to revise License Condition 2.C(19)f to remove the requirement to modify control room lighting prior to startup following the first refueling outage.

Proposed Change NPF-10-87 is a request to revise Technical Specification 3.3.3.9, Table 3.3-13, RADIOACTIVE GASEOUS EFFLUENT MONITORING INSTRUMENTATION to allow the use of the plant vent stack monitor to monitor containment purge effluent. Pursuant to 10 CFR 170.22, the following determinations have been made and the corresponding fees are remitted:



This amendment application consists of the following proposed changes to Facility Operating License NPF-15:

Proposed Change NPF-15-78 is a request to revise License Condition 2(c)12, Fire Protection, to be consistent with the requirements of Standard Technical Specifications with regards to the inclusion of fire extinguishers in Technical Specifications.

Proposed Change NPF-15-79 is a request to revise Technical Specifications 6.9.1.10, 6.13, 6.14 and 6.15 to correct an inconsistency relating to review of revisions to the Offsite Dose Calculation Manual, Process Control Program and major change to the Radioactive Waste Treatment Systems.

Proposed Change NPF-15-82 is a request to revise License Condition 2.C(17)c to remove the requirement to modify control room lighting.

Proposed Change NPF-15-88 is a request to revise Technical Specification 3.7.1.2, AUXILIARY FEEDWATER SYSTEM, to allow entry into the operation in MODE 3, prior to initial criticality, with one motor-driven auxiliary feedwater pump inoperable.


