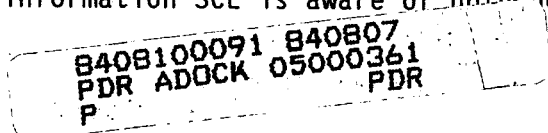

San Onofre Nuclear Generating Station  
Units 2 and 3

The Nuclear Regulatory Commission's (NRC) letter dated April 16, 1984 requested additional information concerning proposed changes to the San Onofre Nuclear Generating Station (SONGS) Units 2 and 3 Technical Specifications. Southern California Edison Company (SCE) believes that the requested information was fully provided with each original submittal. However, in order to facilitate approval of the proposed changes, SCE has extracted the requested information from the proposed changes and is resubmitting this information in the form specified by Enclosure I of the above mentioned NRC letter.

Information in the requested format is enclosed for the proposed changes specified in Table 1. Similar information was not requested for Proposed Change Numbers 52, 108, 111, 119, 125, 127, and 138, but, as indicated in Table 1, SCE is providing similar information for these recently submitted proposed changes in anticipation of future information requests. The information requested for Proposed Change Numbers 8, 83, 89, 99, 100, 101, 102, 103, 131, and 146 is currently being prepared in a similar manner for submittal at a later date. The information requested for Proposed Change Numbers 4, 98, and 144 is not enclosed, since Proposed Change Numbers 4 and 98 were prenoticed in the Federal Register on June 20, 1984 and May 23, 1984, respectively, and Proposed Change Number 144 was approved for Unit 3 and rejected for Unit 2 by NRC letter dated March 13, 1984.

Approval of the proposed changes for which the specified information is enclosed will provide substantial benefits to the SONGS Units 2 and 3 operation. In addition to providing operational benefits, Proposed Change Numbers 52 and 138 form part of the ground rules for the SONGS Unit 2 Cycle 2 reload analysis. As such, approval of Proposed Change Numbers 52 and 138 is required in support of Cycle 2 operation. Upon submittal of the enclosed information SCE is aware of nothing which will prohibit prenoticing of all

these changes in the Federal Register. In that the required prenoticing is critical to the timing of the proposed change approval, SCE requests that the proposed changes for which additional information is enclosed be prenoticed in the Federal Register at the earliest opportunity.
