San Onofre Nuclear Generating Station, Unit 3

Based upon discussion with your staff November 15, 1982 regarding staffing and training of licensed operators, SCE will establish a subcommittee reporting to the Nuclear Control Board to review and evaluate the:

- a. Readiness of plant operations personnel to conduct intended operation and testing, including the adequacy of staffing levels and plans to control and reduce required overtime.
- b. Past performance in plant operations and adherence to procedures and administrative controls.
- c. Adequacy of the operator training program, including a comparison to other PWR training programs.
- d. In performing their review and evaluation the subcommittee shall consider and report on how company management can assist in improving the overall effectiveness of the plant operating staff.

The subcommittee shall be composed of a minimum of three professionals (independent of SCE operating staff and using consultants as necessary) with experience necessary to be responsive to the concerns presented above. In conducting these evaluations, the subcommittee shall conduct interviews of representatives of all levels of shift operating staffs. The subcommittee shall report to the Chairman of the Nuclear Control Board. SCE shall submit a copy of their report to NRC and corrective actions planned no later than 2 weeks prior to exceeding 5% power.
