NEW DATES FOR TRAINING COURSES POSTPONED DUE TO GOVERNMENT SHUTDOWN (FSME-13-117)

Purpose: To provide new dates for training courses postponed due the government shutdown.

Discussion: NRC's Technical Training Center (TTC) has rescheduled the training classes postponed due to the government shutdown. Students already scheduled to attend the above classes will be given the opportunity to attend the rescheduled session. Brenda Usilton will contact the affected students to determine their availability to attend the rescheduled training session.

If there are additional seats available to the Agreement States for the rescheduled sessions, a separate announcement will be sent to all Agreement States to solicit additional students interested in attending the session.*
