Subject: Docket Nos. 50-361 and 50-362 Proposed Technical Specification Change No. NPF-10/15-407 Control Room Emergency Air Cleanup System San Onofre Nuclear Generating Station Units 2 and 3

This letter requests revision of Technical Specification 3/4.7.5, "Control Room Emergency Air Cleanup System," to delete requirements for duct heaters and diverting valves, and to incorporate some modifications in the Action statement, SURVEILLANCE REQUIREMENTS, and Bases.

Provided as an enclosure to this letter are Amendment Application Numbers 116 and 100 to Facility Operating License Numbers NPF-10 and NPF-15 for San Onofre Units 2 and 3, respectively. The Amendment Applications are comprised of proposed Technical Specification Change NPF-10/15-407 (PCN-407). PCN-407 is the request to revise the Control Room Emergency Air Cleanup System Technical Specification 3/4.7.5.

The proposed change would delete the surveillance requirements associated with heaters in the emergency ventilation supply units because (1) the heaters are not required to maintain the operability of filters in the emergency ventilation supply unit since these filters are not credited in the dose analyses, and (2) the heaters are not necessary to maintain the relative humidity below the required 70% at the filters in the emergency recirculation unit which are credited in the dose analysis. In addition this proposed change includes revisions to the ACTION statement and SURVEILLANCE REQUIREMENTS to be consistent with the design of San Onofre Units 2 and 3.
