The Southern California Edison Company (SCE) formally submitted Proposed Change NPF-10/15-135, which concerns Toxic Gas Isolation System setpoints, to the Nuclear Regulatory Commission (NRC) by SCE letter dated April 6, 1984. Additional information pertaining to this proposed change was provided by SCE letter dated August 7, 1984. During an August 31, 1984 phone call, the NRC staff requested the submittal of the control room toxic gas concentration calculations which support Proposed Change NPF-10/15-135.
