Volume 50, Number 10 of the Federal Register, dated January 15, 1985 provided notice of availability of and request for comments on the NRC Fire Protection Policy Steering Committee Report on fire protection policy recommendations. In this notice, the NRC Staff requested public comment on the recommendations made by the Fire Protection Policy Steering Committee to expedite compliance with fire protection requirements. The comment period on the fire protection policy recommendations, provided as an enclosure to Generic Letter 85-01, dated January 9, 1985, is scheduled to expire February 14, 1985.

Based on the magnitude of the enclosure to Generic Letter 85-01, the numerous clarifications provided for requirements promulgated by 10 CFR 50, Appendix R and since the generic letter did not arrive at Southern California Edison Company (SCE) until January 22, 1985, SCE respectfully requests a thirty (30) day extension of the established comment period.
